

# Privacy Policy

Rock Mapper Pty Ltd built the Rock Mapper app as a Free app with a Paid cloud-sync account. This SERVICE is provided by Rock Mapper Pty Ltd and is intended for use as is.

This page is used to inform visitors regarding our policies with the collection, use, and disclosure of Personal Information if anyone decided to use our Service.

If you choose to use our Service, then you agree to the collection and use of information in relation to this policy. The Personal Information that we collect is used for providing and improving the Service. We will not use or share your information with anyone except as described in this Privacy Policy.

## Information Collection and Use

For a better experience, while using our Service, we may require you to provide us with certain personally identifiable information, including but not limited to user name. The information that we request will be retained by us and used as described in this privacy policy.

## Log Data

We want to inform you that whenever you use our Service, in a case of an error in the app we collect data and information (through third party products) on your device called Log Data. This Log Data may include information such as your device Internet Protocol (“IP”) address, device name, operating system version, the configuration of the app when utilizing our Service, the time and date of your use of the Service, and other statistics. Like most websites, cloud.rockmapper.net collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Cloud.rockmapper.net’s purpose in collecting non-personally identifying information is to better understand how cloud.rockmapper.net’s users make use of the cloud-syncing service.
